Frequently Asked Questions

➤ Why a Foundation?

A: In March of 1988, the Paradise Valley United Methodist Church established a Foundation to provide an avenue by which members and friends of PVUMC can express their Love of CHRIST and continue to support the work of GOD.

➤ What is the Foundation?



A: The Foundation is a tax exempt 501 (c) 3 organization created to accept gifts, both current and deferred through Last Wills and

Testaments as well as Living Trusts.

➤ What does the Foundation support?

A: The Foundation funds programs, ministries outreach and other extensions of PVUMC that are outside of the parameters of the operating budget. Funding has supported new church development, scholarships, and missions.



FAQ's Continued:

➤ Who administers the Foundation?

A: A Board of Directors composed of members of Paradise Valley United

Methodist Church is elected by the annual church conference. Directors are divided into classes and serve three year terms.

➤ Why should I support the Foundation?

A: Your support through current gifts, deferred gifts, Last Wills, Trusts or Gift Annuities is an expression of your commitment to Christian Stewardship.

➤ How can I get more information?

➤ How can I support the Foundation's Mission?

A: **OUTRIGHT GIFTS** such as Cash, Stocks, Bonds, Real Estate, Personal Property, and Collectibles can and in most cases will be accepted. We even have experts who can teach you about the tax advantages that result from making such gifts.

LIFE INSURANCE can be given to the Foundation by naming it as both the owner and beneficiary of your policy. The Foundation can also be named as contingent beneficiary if family members do not survive the insured.

LIFE INCOME GIFTS are gifts that provide you with immediate income tax deductions as well as lifetime income. The remainder of such gifts, revert to the Foundation. At the time these gifts are created, you can dedicate the remainder for a specific purpose consistent with the mission of the Foundation. Examples of such gifts include: Gift Annuites, Charitable Lead Trusts, Charitable Remainder Unitrusts and more.
