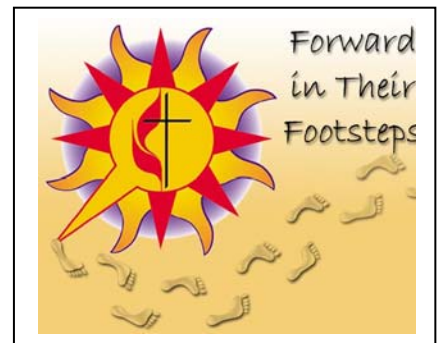


# FOOTSTEPS CAMPAIGN PROGRESS REPORT As of March 14, 2008

- ☆ With 1 "Kick Off" to go, 20,057 "footsteps kits" have been distributed.
- ☆ There are 7,205 "kits" yet to be mailed or shipped.
- ☆ When all mailings and shipping's are completed, we will have distributed 27,261 "kits."
- ☆ To date, more than 650 "kits" have been returned for various reasons: 1) "insufficient address," 2) "moved – no forwarding address," 3) "no receptacle," 4) "attempted not known," etc. This means that our churches' mailing lists have, overall, been 96.7% accurate.
- ☆ Including 11 churches that have indicated they are doing their own campaigns which will include "Footsteps" as the mission component of said campaigns, 121 churches are participating in the Forward in Their Footsteps Endowment Fund Campaign!
- ☆ As of 3/14/08, members from 60 churches have returned their pledge forms!
- ☆ There are 11 "Major Donors" who have pledged an average of \$23,333 each.
- ☆ The DSUMF pledged and gifted \$127,572. Directors and staff of DSUMF have personally pledged an additional \$9,200.
- ☆ Not including "Major Gifts," the average pledge per response to the mailing is \$767.
- ☆ The following churches have already achieved more than 10% of their goals!
